## THE DIRECTOR

**CONSIDERING** D.D. n. 409 of 15/07/2022 with which the announcement was issued for admission to the two-year Master's Degree Course held exclusively in English in **Architecture - Interior Design and for Autonomy**, class LM-4 (Class of Master's Degrees in Architecture and Building Engineering - Architecture), at the Department of Architecture and Industrial Design of the University of Campania "Luigi Vanvitelli" aa 2022/2023 for a number of places as indicated below:

- n. 50 places for Italian citizens, EU citizens and non-EU citizens residing in Italy pursuant to art. 26 of Law 189/02, among which will be selected:
- n. 5 students who will take the course at the Okan University of Istanbul (TR), in the second semester of the first year, on the basis of a specific International Cooperation Agreement signed between the University of Campania "Luigi Vanvitelli" and the Okan University of Istanbul the 01/07/2020,
- n. 5 students will be selected to take the course in the first semester of the second year, at the East China Normal University School of Design in Shanghai China on the basis of a specific international cooperation agreement stipulated between the University of Campania "Luigi Vanvitelli" and the East China Normal University School of Design in Shanghai China on 30/05/2022;
- n. 15 places reserved for non-EU citizens residing abroad and not included in the aforementioned art. 26 of Law 189/02;

**CONSIDERING** the note dated 16/01/2023 with prot. no. 4262, with which the Director of the Department of Architecture and Industrial Design of this University, requests the reopening of the terms for enrolment in the aforementioned study course;

**CONSIDERING**, that as of 21/10/2022, the deadline for enrolment, 14 (fourteen) students have been enrolled (fourteen) students and that, therefore, 36 (thirty-six) places are still available for Italian citizens, EU citizens and non-EU citizens residing in Italy as per art. 26 of Law 189/02 and that there are no students with non-EU citizenship residing abroad and that, therefore, 15 (fifteen) places are still available for non-EU citizens residing abroad and not included in the above-mentioned art. 26 of Law 189/02;

## **DECREES**

For the reasons mentioned in the premises:

- 1) The deadlines for participation in the call for applications for enrolment in the Biennial Master of Science Degree Course in Architecture Interior Design and for Autonomy exclusively in English are reopened for the academic year 2022/2023 to cover the 36 (thirty-six) places available for Italian citizens, EU citizens and non-EU citizens resident in Italy, citizens and non-EU citizens resident in Italy pursuant to Article 26 of Law 189/02, and of the 15 (fifteen) posts reserved for non-EU citizens residing abroad and not included in the above-mentioned Article 26 of Law 189/02.
- 2) The application to take part in the competition must be submitted exclusively via computerised procedure, starting from 20/01/2023 and no later than 12:00 noon of 20/02/2023 according to the procedures indicated in art. 3 of the competition notice (D.D.388/2021).
- 3) Students who have not demonstrated their knowledge of English by presenting the appropriate certificate must take the English language proficiency test on **22/02/2023** at **09:00** a.m. in the Department of Architecture and Industrial Design.
- 4) The classification of those admitted, drawn up on the basis of the criteria indicated in art. 5 of the admissions announcement, will be published on the website of this University: <a href="www.unicampania.it">www.unicampania.it</a> and posted on the Noticeboard of the Office of the Architecture and Industrial Design Students Secretariat on 27/02/2023 by 4.00 pm. This publication constitutes official notification to the interested parties;
- 5) Those who are admitted will be able to enroll from 27/02/2023 and by 12.00 on 02/03/2023, following the procedure indicated in art. 6 of the aforementioned admissions notice, without paying any late payment fine;
- 6) The winners interested in taking the course at the OKAN University of Istanbul (TR) or at the East China Normal University School in Shanghai (China), must opt by **10/03/2023**, by submitting an application by email to the address <u>segarchitettura@unicampania.it</u> should the options exercised for this purpose exceed 5 for each agreement, the five candidates with the highest score in the final ranking will be selected.
