Subject: Decree to reopen the admissions procedure for the two-year Master's Degree course held exclusively in English in Architecture – Interior Design and for Autonomy A.Y. 2017/2018.

THE DIRECTOR

CONSIDERING the D.D. n.471 dated 05/07/2017 which opened the admissions procedure to the two-year Master's Degree held exclusively in English in Architecture – Interior Design and for Autonomy at the Department of Architecture and Industrial Design of the University of Campania "Luigi VANVITELLI" A.Y. 2017 / 2018 for the number of places as indicated below:

- 50 places for Italian citizens, EU citizens and non-EU citizens residing in Italy as per art. 26 of Law 189/02 *. Among the 50 students, the following will be selected:
 - 5 students who will take the course at the Okan University of Istanbul (TR), in the second semester of the first year, by virtue of the specific International Cooperation Agreement stipulated between the University of Campania "Luigi Vanvitelli" and the Okan University of Istanbul, on 25.05.2015;
 - 5 students who will take the course, in the first semester of the second year, at the East China Normal University School of Design in Shanghai - China by virtue of the specific International Cooperation agreement stipulated between the University of Campania "Luigi Vanvitelli" and the East China Normal University School of Design in Shanghai - China, dated 16.05.2016;
- 15 places reserved for non-EU citizens resident abroad and not included in the aforementioned art. 26 of Law 189/2002;

CONSIDERING the note prot. n. 171502 dated 05/12/2017 with which the Director of the Department of Architecture and Industrial Design requested the reopening of the admissions procedure to the two-year Master's Degree Course held exclusively in English in Architecture – Interior Design and for Autonomy in order to fill the places left available until 19/01/2018;

CONSIDERING that as of 20/10/2017, the deadline for the enrolment, 12 applications had been submitted for enrolment and therefore there are still 38 places available for Italian citizens, EU citizens and non-EU citizens resident in Italy as per art. 26 of Law 189/02* and 15 places reserved for non-EU citizens resident abroad and not included in the aforementioned art. 26 of Law 189/2002;

CONSIDERING the D.R. n. 712 of 25/03/2011 with which it has been delegated to the Responsible Directors of the Divisions "omissis...the adoption of the administrative acts and provisions, including all the acts that commit the administration competence of the Rector;

CONSIDERING that this provision falls within those whose enactment was delegated by the aforementioned D.R. n. 712/2011 to the Manager of the Management of Student Careers and Services Division;

DECREES

For the reasons mentioned in the preamble:

- 1) the admissions procedure for the two year Master's Degree, held exclusively in English in Architecture – Interior Design and for Autonomy at the Department of Architecture and Industrial Design of the University of Campania “Luigi VANVITELLI” A.Y. 2017/2018 has been reopened to fill the 38 available places for Italian citizens, EU citizens and non-EU citizens resident in Italy as per art. 26 of Law 189/02 * and 15 places reserved for non-EU citizens resident abroad and not included in the aforementioned art. 26 of Law 189/2002.
- 2) The application to be admitted to the degree course must be submitted only electronically, starting from **December 18th, 2017 and no later than 12.00pm on January 19th 2018** according to the procedures indicated in art. 3 of the admissions procedure announcement (Legislative Decree No. 471 of 05/07/2017).
- 3) Students who have not demonstrated adequate knowledge of English by submitting a specific certificate will have to take an English proficiency test on **22 January 2018 at 10.00am** at the Department of Architecture and Industrial Design.
- 4) The classification of the candidates admitted, drawn up according to the criteria indicated in art. 5 of the admissions procedure announcement, will be published on the Noticeboard of Student Registry as well as the University website at www.unicampania.it by **January 25, 2018 at 3.30 pm**.
- 5) Candidates admitted will be able to enroll from **29 January 2018 to 02 February 2018** according to the procedures indicated in art. 6 of the aforementioned admissions procedure announcement without having to pay any late registration fine.
