**Subject: Decree reopening terms of admission to the Biennial Master's Degree Course in English in Architecture - Interior Design and for Autonomy a.y. 2021/2022.**

### THE DIRECTOR

**CONSIDERING** D.D. n. 388 of 13/07/2021 with which the announcement was issued for admission to the two-year Master's Degree Course held exclusively in English in **Architecture - Interior Design and for Autonomy**, class LM-4 (Class of Master's Degrees in Architecture and Building Engineering - Architecture), at the Department of Architecture and Industrial Design of the University of Campania "Luigi Vanvitelli" aa 2021/2022 for a number of places as indicated below:

- n. 50 places for Italian citizens, EU citizens and non-EU citizens residing in Italy pursuant to art. 26 of Law 189/02, among which will be selected:

- n. 5 students who will take the course at the Okan University of Istanbul (TR), in the second semester of the first year, on the basis of a specific International Cooperation Agreement signed between the University of Campania "Luigi Vanvitelli" and the Okan University of Istanbul the 01/07/2020,

- n. 15 places reserved for non-EU citizens residing abroad and not included in the aforementioned art. 26 of Law 189/02;

**CONSIDERING** the note dated 12/01/2022 with prot. 2851, with which the Director of the Department of Architecture and Industrial Design of this University, requests the reopening of the deadlines for enrollment in the aforementioned course of study;

**CONSIDERING** that as of 11/17/2021, the deadline for enrollment, 10 (ten) students are enrolled and that, therefore, there are still no. 40 (forty) places for Italian citizens, EU citizens and non-EU citizens residing in Italy pursuant to art. 26 of Law 189/02 and there are no registered students with non-EU citizenship residing abroad and who, therefore, are still available no. 15 (fifteen) places for non-EU citizens residing abroad and not included in the aforementioned art. 26 of Law 189/02;

**CONSIDERING** that as of 01/12/2021 no request has been received, pursuant to art. 6 of the D.D. n. 388/2021, for the purpose of exercising the option for the 5 places for students who will carry out the second semester of the first year at the Okan University of Istanbul (TR), according to the provisions of the International Cooperation Agreement signed between the University of Campania "Luigi Vanvitelli" and the Okan University of Istanbul, on 01/07/2020;

**CONSIDERING** the University statute issued with D.R. n. 645 of 17 October 2016 and in particular Article 18 entitled "Directors";

### DECREES

For the reasons mentioned in the premises:

1) the terms for participation in the call for applications for enrollment in the Biennial Master's Degree Course in Architecture - Interior Design and for Autonomy (- held exclusively in English -

for the a.y. 2021/2022, to cover the n. 40 available places for Italian citizens, EU citizens and non-EU citizens residing in Italy pursuant to art. 26 of Law 189/2002, are no. 15 (fifteen) places for non-EU citizens residing abroad and not included in the aforementioned art. 26 of Law 189/02;

2) The application for participation in the admissions procedure must be submitted exclusively through an IT procedure, starting from **27/01/2022 and no later than 12.00 on 18/02/2022** according to the procedures indicated in art. 3 of the admissions notice (D.D. 388/2021).

4) Students who do not demonstrate knowledge of the English language by presenting a specific certificate will have to take the English test on **22/03/2022 at 10.00** at the Department of Architecture and Industrial Design;

5) The classification of those admitted, drawn up on the basis of the criteria indicated in art. 5 of the admissions announcement, will be published on the website of this University: [www.unicampania.it](http://www.unicampania.it) and posted on the Noticeboard of the Office of the Architecture and Industrial Design Students Secretariat on **28/02/2022 by 12.00 pm**. This publication constitutes official notification to the interested parties;

6) Those who are admitted will be able to enroll **from 03/03/2022 to 10/03/2022 by 12.00pm** following the procedure indicated in art. 6 of the aforementioned admissions notice, without paying any late payment fine;

7) The winners interested in taking the course at the OKAN University of Istanbul (TR) must opt by **25/03/2022** by submitting an application by email to the address [segarchitecture@unicampania.it](mailto:segarchitecture@unicampania.it) should the options exercised for this purpose exceed 5 for each agreement, the five candidates with the highest score in the final ranking will be selected;
