ADMISSION TO THE TWO-YEAR MASTER'S DEGREE COURSE IN ENGLISH IN "ARCHITECTURE- REGENERATION OF THE BUILT ENVIRONMENT"

AT THE DEPARTMENT OF ARCHITECTURE AND INDUSTRIAL DESIGN OF THE UNIVERSITY OF CAMPANIA "LUIGI VANVITELLI" ACADEMIC YEAR 2023/2024

For the academic year 2023/2024, this notice is for the opening of the procedure based on academic qualifications for admission to the two-year Master's Degree Course held exclusively in English in "Architecture – Regeneration of the Built Environment" class LM-4 (Class of Master Degrees in Architecture and Construction Engineering - Architecture) Code B87 at the Department of Architecture and Industrial Design of the University of Campania "Luigi Vanvitelli", for the n. **56** (**fifty-six**) places, assigned as follows:

a) **41 (forty-one)** places for Italian citizens, EU citizens and non-EU citizens resident in Italy, as per art. 26 of Law 189/2002, among which:

- n. 5 (five) students will be selected to take the course at the Okan University of Istanbul (TR), in the second semester of the first year, according to a specific International Cooperation Agreement signed between the University of Campania "Luigi Vanvitelli" and the Okan University in Istanbul on 01.07.2020 (updated on 07.06.2023).
- n. 5 (five) students will be selected to take the course at the East China Normal University di Design di Shanghai (China), in the first semester of the first year, according to a specific International Cooperation Agreement signed between the University of Campania "Luigi Vanvitelli" and the East China Normal University di Design di Shanghai (China) on 12 July 2023.
- b) 15 (fifteen) places being reserved for non-EU citizens residing abroad.

Article 2) REQUIREMENTS TO PARTICIPATE IN THE ADMISSIONS PROCEDURE

1. There are **41 (forty-one)** places for Italian citizens, EU citizens residing anywhere and non-EU citizens under art. 26 of Law n. 189/2002, who hold a Class 4 bachelor's degree, according to D.M. 509/99 (now Class L-17, according to D.M. 270/04), awarded by any Italian university, or other equivalent qualification obtained abroad. For anyone holding a bachelor's degree in another class, admission is conditional to the possession - with reference to the individual disciplines - of at least 108 credits (ETCS) as set out by D.M. 16/03/2007 (Attachment n. 2) for the Degree Class L-17 in Architectural Science. The presence of any debts precludes admission to the master's degree.

2. There are 15 (fifteen) places for non-EU citizens resident abroad included in the lists of applications for early enrolment for Degree Courses in Architecture of this University, produced by the aforementioned non-EU citizens and transmitted to this University by the Italian Diplomatic and Consular representatives in their respective countries of origin.

3. Knowledge and understanding of English is also requested (at least B2 level according the CEFR). Applicants can submit an appropriate certificate issued by a certified school or cultural institute in Italy or abroad (Attachment n. 3) via email to the following address: uff.segreteriastudentiarchitettura@unicampania.it

Foreign citizens are also required to have knowledge of the Italian language at a level not lower than B2 of the Common European Framework of Reference for Languages (CEFR). Applicants can submit by the deadline of this notice an appropriate certificate issued by an authorised school or cultural institute in Italy or abroad by e-mail to the following address: uff.segreteriastudentiarchitettura@unicampania.it

Alternatively, applicants will have to take an English language test on 22 January 2024 at 9:30 a.m., and an Italian language test on 22 January 2024 at 10:30 a.m.

With subsequent notice published on the University website in the section "Admission to limited number courses" will be communicated how the English and Italian tests will be carried out.

Participants must fulfil the admission requirements, referred to in this Article, on the date of submission of the application form. In the event that the requests received to participate in the admissions procedure, within the terms set out in the following art. 3, are lower than the number of places available, candidates who submitted the aforementioned application and have taken the TEST/OFA ENGLISH TOLC-E, online at home (TOLC@CASA), who meet the requirements of this call for applications, have the right to enroll in the terms set out in the following art. 7.

5. All the candidates are admitted with reserve to the admissions procedure. The Administration may at any time, by reasoned provision, exclude the prescribed requirements by default or false declarations; this provision will be notified to the interested party by registered letter with acknowledgment of receipt.

6. The University reserves the right to issue a further call for applications to fill the remaining places.

Article 3) HOW TO APPLY AND TAKE THE TOLC

1. Candidates who have already taken the TOLC

Candidates who have already taken the TOLC ENGLISH TOLC-E, to the purpose of the present procedure, from January 2023 and not later than November 30th, 2023, may apply for the selection. The score obtained in the TOLC ENGLISH TOLC-E by the forementioned candidates may be considered valid for their position in the rankings.

To this purpose, candidates must apply for the admission to the two-year master's degree course in English in "Architecture- Regeneration of the built environment" (LM-4) of the Department of Architecture and Industrial Design of the University of Campania "Luigi Vanvitelli", a.y. 2023-2024.

Candidates must apply to participate in the admission procedure using the credentials to access the University's exclusively on-line (website: https://www.unicampania.it/ - Servizi per Studenti > Concorsi on line – click on > ACCEDI), starting from December 7th, 2023, and no later than January 12th, 2024.

The application may be submitted - 24 hours non-stop - from any network-connected computer.

Anyone who does not already have access credentials to the web services of this University will have to register first.

Once logged on to the online services for students, click on **Segreteria/Test di Ammissione/Iscrizione Concorsi**, select "**Laurea Magistr**ale" and select "**Architecture -Regeneration of Built Environment** (Architettura - Rigenerazione dell'Ambiente Costruito), then continue with the various screens proposed by the online procedure.

The aforementioned online procedure will be deactivated, precisely and automatically, at 11:59 p.m. on January 12th, 2024.

Failure to submit an application to take part in the admissions procedure by the terms and conditions set out above for the aforementioned two compulsory stages precludes any possibility of taking part in the procedure.

The Administration, at each stage of the procedure, reserves the right to ascertain the truthfulness of the substitutive declarations of certification or deeds of notoriety made by the candidates, in accordance with current legislation on the subject; the candidate, therefore, must provide all the necessary elements to allow the Administration to carry out the appropriate checks.

All candidates are admitted subject to the procedure set out in this admission notice.

The Administration may, by reasoned decree, proceed at any time, exclude the candidate from the competition for failure to meet the prescribed requirements.

2. Candidates who have not taken the TOLC yet.

The TOLC ENGLISH TOLC-E test will be available exclusively on January 18th, 2024, for those candidates who have not taken it within the aforementioned dates.

The test will take place on January 18th, 2024, at 2.30 p.m. according to the indications given at <u>https://www.cisiaonline.it</u>.

In order to be admitted to the test on 18 January 2024 at 2.30 pm, relating to the admission - A.A. 2023/2024,in the two-year Master's Degree Course in "Architecture-Regeneration of Built Environment", candidates will have to apply by using the credentials to access the University's exclusively on-line (website: https://www.unicampania.it/ - Servizi per Studenti > Concorsi on line – click on > ACCEDI), starting from December 7th, 2023, and no later than January 12th, 2024.

An admission fee of Euro 30,00 is required to be paid, under penalty of exclusion, no later than January 12th, 2024, at 11:59 p.m.

Participation fees payments are made through the PagoPA system, set up by the Digital Italy Agency (AgID) - Agenzia per l'Italia Digitale (AgiD) to simplify payments to the Public Administration. PagoPA payment methods:

ONLINE: by credit card, bank account, money transfer, PayPal, etc.

IN PERSON: by printing a pdf form (generated as part of the aforementioned IT procedure for registering for the competition) and paying at authorized shops (including tobacco shops where SisalPay or Lottomatica service is active) or at one of the banks with PAgoPA system.

Registration for the competition is to be considered concluded only after payment of the aforementioned contribution, within the terms and according to the methods indicated in this announcement.

• THE FORMAT OF THE TEST/OFA

The TEST/OFA (TOLC ENGLISH TOLC-E) consists of 36 questions divided into 3 sections. The sections have a predetermined number of questions and each section has a set time i.e.

- Mathematics 13 guestions/time available 30 minutes;
- Logic 13 questions/time available 30 minutes;
- Text comprehension 10 questions/ time available 30 minutes
- Total time available 90 minutes

Each question is multiple choice, only one of which is correct. The result is determined as follows:

- 1 point for each correct answer
- 0 points for each incorrect answer
- Penalty of 0.25 points for each incorrect answer

Applicants are required to abide by the rules and conduct set out in art. 4.2 of the TOLC Regulations, published on the CISIA website at the link below: <u>https://www.cisiaonline.it/area-tematica-tolc-cisia/regolamenti</u>

The score obtained, immediately viewable on the screen at the end of the test will be recognised as official and made available only from 7 p.m. 48 hours after the end of the TOLC@CASA.

At the end of the test, the Commissioners may access the recordings made and verify the proper conduct of the tests, as well as take into account reports of any abnormal behaviour in the use of the client or the SEB application by CISIA.

After 48 hours from the end of the TOLC@CASA, the person who has correctly carried out the test, following the rules and behaviour indicated in the regulation, will have their TOLC@CASA result recognised and will be able to access the result certificate.

• CANDIDATES HAVING AN ACAEMIC QUALIFICATION OBTAINED ABROAD

Candidates in possession of an academic qualification obtained abroad **must submit**, by the expiry date of this notice, to the Head of the Procedure, dr. Giulio GAGLIONE, by registered letter with return receipt addressed to the aforementioned "Head of the admissions procedure - a.a. 2023/2024 - "c/o ARCHIVE AND PROTOCOL OFFICE - UNIVERSITY OF CAMPANIA STUDIES "LUIGI VANVITELLI" - P.zza LUIGI MIRAGLIA (I POLICLINICO) – 80138 NAPLES, or by personal PEC of the candidate, at the address protocollo@pec.unicampania.it, the application for recognition, together with the documentation below.

Applications received from a PEC address with a name different from that of the applicant will not be evaluated.

Candidates who do not possess a PEC email address may, as an alternative to the above, submit the application for recognition of the foreign academic qualification by the deadline to the **Student Secretariat Office of the Department of Architecture and Industrial Design**, by appointment to be agreed with the director of the structure, by sending a specific e-mail to the institutional address <u>uff.segreteriastudentiarchitettura@unicampania.it</u>.

In detail, candidates in possession of an academic qualification obtained abroad must attach the following documentation:

- a) Application for recognition of the foreign academic qualification possessed, addressed to the Rector of the Università della Campania "Luigi Vanvitelli;
- b) Original of the secondary school qualification to enter the University that issued the degree;
 c) Original analytical certificate of the university examinations issued by the aforementioned university;
- c) Programs of each examination;
- d) **Original** copy of academic qualification;
- e) Receipt certifying payment of the amount for the recognition of foreign degrees for the academic year 2023/2024 amounting to €100,00.

The documents in points b) c) d) and e) should be provided with an official translation, for those related to points b) and e) legalization is required and they should be accompanied by a "declaration of local value", provided by the Italian Diplomatic and Consular representatives in the State in which the qualifications are issued, which will also confirm the authenticity of the documents referred to in paragraphs c) and e).

The Administration, with a reasoned decree, may at any time exclude from the admissions procedure any candidate who fails to meet the prescribed requirements.

Article 4) CRITERIA AND PROCEDURE FOR THE APPOINTING OF A COMMISSION IN CHARGE OF THE ADMISSIONS TEST AND THE HEAD OF THE PROCEDURE

The Commission responsible for the admission test will be appointed with a subsequent Executive Order and composed of a President and 4 components and one substitute nominated from the academic staff of the Department of Architecture and Industrial Design.

The Commission has all the responsibility for the smooth running of the selection procedure and the definition of the relative ranking according to the procedures and criteria set out in this Notice. All the procedures carried out by the Commission shall be reported in the appropriate minutes,

initialed on each page and signed by the President and all the members of the Commission. Pursuant to art. 4 of Law n. 241 of 07.08.1990 (New rules of administrative procedure and the right of access to administrative documents) and to the University Regulations for the implementation of Act 241/90 (by D.R. n. 622 of 26/07/2018) the Director of the Student Registry of the Department of Architecture and Industrial Design, Dr. Giulio GAGLIONE, will be appointed as Head of the entire admissions procedure.

The members of the Commission and the Head of the admissions procedure, prior to accepting the appointment and after consultation of the records containing the names of the candidates participating in the admissions procedure, must release a statement claiming not to have any kinship or affinity up to the fourth degree inclusive with the participants as well as not hold a political office.

Article 5) FINAL CLASSIFICATION

The Commission will draw up an overall classification of candidates who, having presented a regular application to take part in the procedure, in compliance with the procedures and deadlines provided for by the aforementioned art. 3 of the present notice, have regularly taken an ENGLISH TOLC-E in the current calendar year 2023 by the date of 28 September 2023 as indicated in art. 3 of the present notice.

The classification is formulated on the basis of the score obtained at the ENGLISH TOLC taken in the aforementioned time period.

Those who have taken the ENGLISH TOLC-E more than once in the aforementioned time period will be awarded, for the purposes of the ranking, the best score obtained.

In the event of a tie in the classification between several candidates, the candidate who has obtained the best score in descending order in solving, respectively, the questions relating to the sections:

- 1) Mathematics
- 2) Logic
- 3) Text comprehension

In the event of a further tie, the candidate who is younger in age prevails.

Candidates who have not answered any questions will not be placed in the classification.

On the basis of the total score and according to the above criteria, two separate rankings will be drawn up separate classifications, one for candidates from EU countries and one for candidates from non-EU countries as per art. 39, paragraph 5, legislative decree no. 286 of 25 July 1998 and the other reserved for candidates from non-EU countries resident abroad.

Article 6) ENROLLMENT OF ADMITTED APPLICANTS

In order to enroll in the degree course in Architecture - Regeneration of the Built Environment (Architettura - Rigenerazione dell'Ambiente Costruito)", it is necessary to be in a relative position in the classification, i.e. within the position that corresponds to the maximum number programmed for the degree course.

Participants who are placed in a position for the purposes of admission to the course acquire the right to enroll in it within the deadline prescribed by the competition notice.

Failure to exercise the right to enroll within the prescribed deadline shall result in forfeiture of said right.

Candidates ranked after the places offered in the competition do not have the right to enrolment, without prejudice to any changes in the rankings specified in art. 8 below.

Those awarded places wishing to take the course at the Okan University of Istanbul (TR) or East China Normal University School of Shanghai (China) will have to opt for this opportunity when registering within February 12th, 2024, not later than 12.00 p.m., via email: <u>uff.segreteriastudentiarchitettura@unicampania.it</u>

If the options exercised for this purpose exceed the number of 5 for each convention, the five candidates with the highest final score will be selected according to Art. 5.

Should the number of applications received by the deadline be less than the number of places available for the competition, candidates who have submitted such an application and who meet the requirements set out in this notice are entitled to enrolment within the terms set out in Article 7 below.

Article 7) TERMS TO BE RESPECTED FOR ENROLLMENT PROCEDURES

Those awarded a place must register and submit a registration application exclusively in accordance with the procedures set out below from January 29th, 2024, and no later than 12:00pm on February 2nd, 2024.

- social security number (mandatory, procedure will be blocked if not uploaded);

During the ONLINE PRESENTATION of the enrolment application, candidates must upload the following documentation to the user's web-area under the "Carriera/Allegati Carriera" section:

- printed and signed copy of registration application (Type of attachment: Registration application);
- copy of the PagoPA receipt for the first instalment of the tuition fees (Attachment type: Receipt of payment of first instalment of tuition fees).

The enrolment application will be considered regularly filled only if, within the terms of the registration itself, there are in the aforesaid computer procedure n. 4 uploads:

- 1. identity document
- 2. social security code,
- 3. signed copy of the registration form
- 4. receipt of payment of the first instalment of the tuition fees

Failure to comply with the foregoing will result in the loss of the right to enrolment. The exact date and time of uploading is recorded in the University database, thus any documents uploaded after



the terms indicated will not be considered valid.

For the academic year 2023/2024, the amount of the regional tax is differentiated on the basis of the I.S.E.E. The relevant amounts and methods of payment of the regional fee are available on the <u>sito web dell'ADISURC</u>.

During the online registration procedure, the applicant must authorise the University to automatically retrieve the I.S.E.E. directly from the INPS database through the reserved web area (Career Data) in order to pay the Regional Tax.

In the absence of ISEE data or in the absence of the aforementioned authorisation for automatic retrieval of the data in question, the student is automatically assigned the maximum band provided for by the Campania Region for the payment of the Regional Fee for the right to study.

Article 8) GOING DOWN THE CLASSIFICATION – REMAINING PLACES AT THE END OF THE REGISTRATION DEADLINE

If there are remaining places after the deadline of February 2nd, 2024, the Student Secretariat Office of the Department of Architecture and Industrial Design will go down the classification.

It shall publish on February 5th, 2024, by 3:00 p.m. the list of those entitled to register as a result of the first going down the classification.

The persons entitled as a result of going down the classification may present a registration application, as set out in the preceding article, starting from February 6th, 2024, and no later than 12.00 p.m. on February 9th, 2024.

In case of further remaining places, the Student Secretariat Office of the Department of Architecture and Industrial Design will go down the classification without prejudice to any other remedy.

The list of those entitled to enrolment due to going do the ranking will be published on the Admission to restricted access Degree Programmes page of the university website (<u>sezione dedicata ai</u> <u>Corsi di Studio a numero programmato</u>,) and posted on the notice board of the Architecture and Industrial Design Student Secretariat Office.

The publication will constitute a formal notification to the parties concerned, in all respects.

Failure to register of those eligible under the terms set out above will result in forfeiture of the right to matriculation in the Academic Year 2023/2024 to the degree course covered by this announcement.

ART. 9) CANDIDATES WITH SPECIAL NEEDS OR SPECIFIC LEARNING DISORDERS.

- 1. Candidates with special needs, in regard to articles 16 and 20 of Law n. 104 of 05/02/1992, updated by Law n. 17 of 28/01/1999, may ask for special arrangements and support, according to the type and degree of need or disability, as well as extended examination time, albeit not longer than 50% over the normal time.
- 2. Candidates who hold a certificate of invalidity or any certificate acknowledged with regar to law n. 104/1992, must exhibit their original certificates or a validated copy in time to arrange the test.



The certificate must be issued by the local medical authority, with proof of the type and degree of acknowledged invalidity.

- 3. Candidates affected by Specific Learning Disorders (SLD), recognized by Law n. 107/2010, must submit a diagnostic certification of SLD, complied by public health Institutes or accredited Institutes, as well as a professional. The diagnosis attesting DSA status must not exceed, at the time of submission, three years since the date of issue, or must be issued after the eighteenth (18) year of age. Such candidates are allowed extended examination time, albeit not longer than 30% over the normal time.
- 4. Candidates with special needs or specific learning disorders living abroad, who intend to ask for special requirements as stated above, must submit a diagnostic certification issued in their own country along with a certified translation into Italian or English. This University committee for disabilities will examine the certification in order to verify that the specific condition of disability meets the requirements acknowledged by Italian law.
- 5. Applications for special requirements or extra time must be submitted, along with the requested certifications as in the above subsections (2,3, and 4) within the expiring date of the present announcement, to the responsible of the procedure, dr. 
